Overall operating results of the Company and its subsidiaries in the consolidated financial statement for the three month period ended 30 September 2020 compared with same period of 2019 are as follows: Revenue decreased by Baht 227 million (25.3%). Profit for the period decreased by Baht 34.0 million (37.0%). and Profit attributable to owners of parent decreased by Baht 25 million (34.1%).

Operating Results:

Overall operating results of the Company and its subsidiaries in the consolidated financial statement for the nine month

period ended 30 September 2020 compared with same period of 2019 are as follows: Revenue decreased by Baht 694 million

(33.6%). Profit for the period decreased by Baht 280.0 million (107.3%), and Profit attributable to owners of parent decreased by

Baht 228 million (116.9%).

1. Revenue from AUTO business decreased in line with the global economic slowdown. Nevertheless, the company

utilized this opportunity to make improvement in cost reduction.

2. Revenue from EPC business decreased due to the majority of projects is towards the project ending phase, in which

the majority of revenue was recognized in the previous phase. For the new projects awarded in 2020, these are in

the initial phase, which is still in progress.

B. Revenue from WATER business decreased due to the draught situation. Nevertheless, the company prepared

sufficient water to deliver to meet the contract. The increase in cost was due to higher wages and depreciation.

FINANCIAL POSITION (Compare to the consolidated financial statement as at December 31, 2019)

Assets

As at September 30, 2020 and December 31, 2019, Assets in the consolidated financial statement are Baht 3,404.3

million and Baht 3,134.7 million respectively, increases Baht 269.6 million (8.6%).

Liabilities

As at September 30, 2020 and December 31, 2019, Liabilities in the consolidated financial statement are Baht 1,658.5

million and Baht 1,259.2 million respectively, increases Baht 399.3 million (31.7%).

Equity

As at September 30, 2020 and December 31, 2019, Equities in the consolidated financial statement are Baht 1,875.5

million and Baht 1,875.5 million respectively, decreases Baht 129.7 million (6.9%).
